

## NON-DISCLOSURE AGREEMENT FOR REFR.YOU BETA TESTING

**Effective Date:** 3<sup>rd</sup> April 2026

By accessing or using the Refr.you beta version, you agree to be bound by this Non-Disclosure Agreement ("Agreement") with Rebar Technology Limited ("Rebar", "We", or "Us"), a Limited Company registered in England and Wales under **Company Number: 16877600**, with its registered office at 8 High Street, Heathfield, East Sussex TN21 8LS. If you do not agree, you **must not** use the Refr.you beta version.

### 1. Purpose

This Agreement protects confidential information shared with you ("Tester" or "You") during the beta testing of Refr.you, a networking platform.

### 2. Definition of Confidential Information

"Confidential Information" includes all information related to Refr.you, including but not limited to:

- The platform's features, functionality, user interface, code, designs, and documentation.
- Feedback, bug reports, test results, or performance data you generate.
- Any personal data (as defined under the UK GDPR) processed during testing.
- Any trade secrets, business plans, or intellectual property of Rebar.

**Exclusions:** Information is not confidential if it is: (a) publicly available without your breach; (b) already known to you without confidentiality obligations; (c) independently developed by you without using our information; or (d) required to be disclosed by law (see Section 6).

### 3. Your Obligations

By using Refr.you, you agree to:

- Use Confidential Information only for beta testing and providing feedback to Rebar.
- Keep all Confidential Information strictly confidential and not share it with anyone, including on social media, forums, or platforms like X, without our prior written consent.

- Not copy, reverse engineer, decompile, or attempt to derive the app's structure or code.
- Take reasonable steps to protect Confidential Information (e.g., secure your devices and accounts).
- Not publish screenshots, videos, or descriptions of Refr.you without our permission.

#### 4. Intellectual Property

- All rights in Refr.you and its Confidential Information remain with Rebar.
- Any feedback or suggestions you provide about Refr.you may be used by Rebar without compensation, and you grant us a perpetual, royalty-free licence to use such feedback.

#### 5. Data Protection

If Refr.you processes personal data, both parties will comply with the UK GDPR and Data Protection Act 2018. You agree to:

- Process personal data only for beta testing as instructed by Rebar.
- Implement reasonable security measures to protect personal data (e.g., secure passwords).
- Notify us immediately of any data breach.
- Not transfer personal data outside the UK without our consent and appropriate safeguards.

#### 6. Permitted Disclosures

You may disclose Confidential Information if required by law or a court order, but you must notify us promptly (where legally permitted) to allow us to seek protective measures.

#### 7. Return or Destruction

At the end of the beta testing period:

- or upon our request, you must delete all Confidential Information relating to Refr.you from your devices and confirm deletion in writing if requested.
- Rebar will delete any information provided by you during the course of the testing period

## 8. Duration

Your confidentiality obligations continue for two (2) years after the beta testing ends, or indefinitely for trade secrets, unless Refr.you is publicly released without confidentiality restrictions.

## 9. Breach and Remedies

Breaching this Agreement may cause irreparable harm to Rebar. We may seek injunctive relief, damages, or other remedies. You will indemnify us for losses caused by any breach.

## 10. Governing Law

This Agreement is governed by the laws of England and Wales. Any disputes will be subject to the non exclusive jurisdiction of the courts of England and Wales.

## 11. Miscellaneous

- Entire Agreement: This is the complete agreement regarding Refr.you beta testing and supersedes prior agreements.
- Severability: If any part is invalid, the rest remains enforceable.
- No Waiver: Our failure to enforce any term does not waive our rights.
- Electronic Acceptance: **By using Refr.you, you electronically agree to this NDA.**
